How to register a PRO position

<u>Click here</u> to register a PRO position on the Plan1 permanent and ad hoc COLA agenda item.

- Under "Committee," use the pull-down menu to choose "Select Committee on Pension Policy."
- Under "Meetings," choose 11/15/2022.
- The menu will provide three agenda items to be covered at the November 15th meeting. Choose "Plans 1 Ad hoc COLA Proposal". Please note that this agenda item will include the permanent COLA proposal for Plan 1 retirees.
- You will then be given one of the following four choices:
 - o "I would like to testify in person during the hearing."
 - o "I would like to testify remotely."
 - o "I would like my position noted in the legislative record."
 - "I would like to submit written testimony."
- Click "I would like my position to be noted in the legislative record."
- You will then be prompted to state your position. Use the pull-down menu to select "PRO."
- Provide your first and last names, email address, organization, city, state, zip code and phone number.
- Click the box to indicate that you are not a robot.
- Push "Submit Registration."

If you have registered correctly, you will immediately receive an email from the Office of the State Actuary (OSA) confirming receipt of your registered position.

How to register to attend the Full Committee Meeting (via Zoom)

<u>Click here</u> to register to attend the Full Committee meeting. There is no separate process for registering to attend the Executive Committee meeting.

- You will be prompted to provide your first and last names and email address.
- Complete all the prompts and push "Submit Registration."

Once you register, you will receive a confirmation email from the Office of the State Actuary (OSA) confirming your attendance and the log-in link.

If you do not receive a computer-generated confirmation email right away, reach out to OSA via email at **state.actuary@leg.wa.gov**. You may also call OSA at (360) 786-6140.

Once you register, please continue to monitor your email. If OSA staff change the log-in link for some reason, you will receive an updated link by email because you have preregistered to attend.

Registering to attend does not register you to provide verbal testimony.

How to attend the meeting in-person

The meeting will take place in **House Hearing Room A in the John L. O'Brien Building**, 504 15th Ave SW, Olympia. Please arrive early so that you can obtain a seat. Seating is provided on a first come first served basis.

We have been told that those who attend in person and have not registered to give testimony may do so if time permits by raising their hands during the meeting. It will be at the Committee Chair's discretion if testimony will be allowed by those attending in person who have not preregistered online to provide in-person verbal testimony.

How to testify in person - House Hearing Room A, John L. O'Brien Building

If you plan to attend in person and provide verbal testimony, Chair Conway and the Office of the State Actuary (OSA) have requested that you register to do so via the website by 9 a.m. on November 15th. We have been told there might be a sign-up sheet at the entrance of the meeting room. This could be another way to provide verbal testimony. That said, it is best if you preregister through the website.

Who will testify first

According to information we received from the Office of the State Actuary (OSA), Chair Steve Conway will first call upon those who have registered, through the website, to provide verbal testimony in-person or remote. Finally, time permitting, he will call upon anyone tuning in through Zoom meeting or in the hearing room who has their hand raised.
